G.1 Resolution No. 2012/13-29 – Resolution of the Board of Education of the Riverside Unified School District Denying the Petition for the Establishment of SPARK Charter School

The Board agreed that this item would be placed on the next Board Instruction Subcommittee agenda to address further questions, and then brought back for second reading and adoption at the January 22, 2013 Board meeting.

this is the position that she currently holds and her term will expire on March 31, 2013. Mrs. Cloud indicated that she would like to continue as one of RUSD's Delegate Assembly representatives.

G.5 Nominations for the California School Boards Association's Delegate Assembly

Mrs. Cloud and Dr. Miller explained that CSBA Subregion 18A has six Delegate Assembly positions that expire in 2013.

Mrs. Cloud shared a video clip with the Board members. She stated that the California School Boards Association (CSBA) has a new website and that it is supposed to be more user-friendly.

Mr. Hunt had no comments.

Mrs. Allavie thanked everyone for the productive time she had at the CSBA Annual Education Conference. She mentioned a recent *Press-Enterprise* article titled, "Chemists Teach Elementary Students the Scientific Method" – where University of California, Riverside (UCR) chemistry department students were helping Taft Elementary School students by giving of their own time by helping the students' prepare for their science fair projects. She suggested that a letter be sent to UCR thanking the department head for coordinating this effort. In closing, Mrs. Allavie said that she had some fundraising ideas that she gathered from the CSBA Conference for bands and ASB groups that she will share with Mr. Hunt and Mrs. Lock-Dawson.

Mrs. Lock-Dawson expressed her confusion and disappointment with the nomination process tonight for Board of Education officers.

Dr. Beaty mentioned an article in the Martin Luther King High School newspaper – *The King Courier* titled, "Making Mole Hills of Mt. Rubidoux", and said that it was written very well. He discussed the Famous Fliers' Wall at the Mission Inn, and he stated recently the wings of the Tuskegee Airmen were placed on the wall.
