# **Action/Discussion Items**

## 1. Approval of Minutes

Kathy Allavie moved and Patricia Lock Dawson seconded the approval of the November 16, 2018 meeting minutes, as presented.

#### 2. Celebrating Student Excellence

The committee received an overview of the Celebrating Student Excellence recognition ceremony which is taking place on April 30, 5:00 p.m. at Ramona High School. Staff reviewed the invitation and program content and highlighted the revisions made per the recommendation of the Board from last year's event.

## 3. College and Career Index

Staff provided a presentation regarding important components and purpose of the College and Career Index (CCI). Staff also reviewed each of the eight paths used in the CCI measures and provided criteria for the formula calculations, and reviewed descriptors and rules used for each CCI Measure. In addition, staff is working on clean data initiative to ensure that our data is accurate as we move forward.

## 4. Graduation Rate

Staff provided information regarding revisions for the 2018-2019 school year and explained the changes to the Graduation Rate Calculation, Indicator, and Status and Change for 2018 Dashboard. Staff also reviewed the Alternative Education Diploma process and highlighted the current supports that are available for students. Staff provided a review of the Graduation Credit Requirements by subject and school configuration. Finally, staff reviewed the procedural changes in RUSD.

## 5. TK-2ELA/ELD Material Adoption Process

The committee received a presentation regarding the TK-2 ELA/ELD Adoption Process. After the thorough process and analyzing different aspects of the materials offered, Wonders was recommended and has been selected. The new program provides Support for Students, Biliteracy, English Language Development, and Foundational Reading Skills. Staff also highlighted that parents will receive resources such as handouts, access to webinars and videos, open house events, and resources through the Family Resource Center.
