

NOTICE OF PUBLIC HEARING OF THE RIVERSIDE UNIFIED SCHOOL DISTRICT APPROVING AN INCREASE IN STATUTORY SCHOOL FEES IMPOSED ON NEW RESIDENTIAL AND COMMERCIAL/INDUSTRIAL CONSTRUCTION PURSUANT TO EDUCATION CODE SECTION 17620 AND GOVERNMENT CODE SECTION 65995

NOTICE IS HEREBY GIVEN that the Board of Education (“Board”) of the Riverside Unified School District (“District”) at its Regular Meeting to be held on July 15, 2021, will conduct a Public Hearing to consider its report entitled, “School Fee Justification Study” (“Study”), and consider adopting a Resolution of the Board of the District to increase Statutory School Facility Fees imposed on new residential and commercial/industrial construction pursuant to Education Code Section 17620 and Government Code Section 65995. The Study justifying such increases is on file at the District’s offices, located at 3070 Washington Street, Riverside, CA 92504. However, based on the limited availability of District personnel due to COVID-19, the Study is currently available for public review on the District’s website through July 15, 2021.
