WHAT IS THE LOCAL CONTROL ACCOUNTABILITY PLAN (LCAP)?

- A three-year plan describing how District funds will be used from the Local Control Funding Formula (LCFF) that is revised and adopted annually
- RUSD's Local Control Accountability Plan (LCAP) combines parent, student, employee, and community feedback with proven learning strategies aligned to RUSD's District Priorities and <u>Guide for Instructional Direction</u>
- All of these resources work together to create an action plan of services that primarily support Foster Youth, English Learner, and Low-Income students


LOCAL CONTROL FUNDING FORMULA (LCFF) AND UNDUPLICATED STUDENTS


- English learners
- Low-income
- Foster Youth
- Unduplicated Students count only once even if they meet more than one criteria
- LCAP funds from LCFF must primarily improve or increase services for these students




HOW DOES THE LCFF FORMULA WORK?








BUDGET OVERVIEW FOR PARENTS 2023-2024
