What is the Federal Program Review? (1)

• Referred to as 'FPM' by staff

- RUSD receives categorical funding from the State and Federal government.
- Examples of categorical funding received:
 - Title I Funds help close the achievement gap
 - Title II Funds support professional development for teachers and site administrators
 - Title III Funds support English learners with improving English language skills
 - Title IV Funds support well-rounded education, safe & healthy school
- •••• environment, and technology for learning

What is the Federal Program Review? (2)

- Districts are responsible for creating and maintaining categorical programs which meet minimum fiscal and programmatic requirements.
- Federal and state laws require the California Department of Education (CDE) to monitor implementation of categorical programs operated by districts.
- School districts that receive funding for certain categorical programs may be chosen for a review by the state.
- The purpose of the review is to ensure that they are spending the funding as required by law.
- At the end of each review, the state will complete a report that details any findings of non-compliance and informs the school, district, or county office how to correct the findings.

April 6-12, 2024

- On-site at the District & 13 school sites
- Includes 12 Programs
- Not every school will be reviewed for every program


