Summary:	(1) This guidance applies to State agencies and school food
	authorities administering the Child Nutrition Programs. (2) This
	guidance provides clarification on allowable flexibilities for
	States experiencing milk supply chain challenges.

USDA's Food and Nutrition Service (FNS) is aware that schools in multiple States are experiencing milk supply chain challenges related to packaging issues. This memorandum provides State agencies with information about existing authority related to schools and other Child Nutrition Program (Program) operators experiencing inadequate milk supply. FNS encourages State agencies to use this authority when needed to support Program operators impacted by the current milk packaging challenges.

Under current Program regulations found at 7 CFR 210.10(d)(2), 220.8(d), 225.16(f)(6), and 226.20(e)(1), State agencies may allow Program operators experiencing milk supply shortages to serve meals during an emergency period with an alternate form of fluid milk or without fluid milk. Although Program operators are expected to meet the fluid milk requirements to the greatest extent possible, supply chain disruptions, including disruptions that limit milk variety or affect serving size, would be considered a temporary emergency condition for purposes of this flexibility. Because this is an existing regulatory flexibility, a waiver is not required for State agencies to exercise this authority. Additionally, State agencies are reminded that administrative

reviews should take into account any waivers or flexibilities that have been provided to Program operators.

FNS appreciates the exceptional efforts of State agencies and Program operators working to meet the nutritional needs of children during this time. State agencies are reminded to distribute this memorandum to Program operators. State agencies with additional questions about this authority or reviews of Program operators using this regulatory flexibility should contact the appropriate FNS Regional Office.

Dear Program Operator:

The California Department of Education (CDE) Nutrition Services Division (NSD) is aware that school nutrition program operators are experiencing milk supply chain challenges related to packaging issues. The CDE NSD recognizes that unanticipated emergency conditions, including supply chain disruptions, may temporarily prevent program operators from offering fluid milk as required by the program's meal pattern. This Listserv provides operators with information about existing flexibilities related to inadequate milk supply issues, strategies for navigating the disruption, and a method of notifying the CDE of your need to utilize the fluid milk flexibilities.

Existing Fluid Milk Supply Flexibilities

On October 25, 2023, the U.S. Department of Agriculture (USDA) issued Policy Memorandum SP 01–2024, CACFP 01–2024, SFSP 01–2024: Clarification of Allowable Flexibilities for Child Nutrition Programs Experiencing Milk Supply Shortages.

This policy memo reminds program operators that State agencies may allow program operators experiencing milk supply shortages to serve meals during an emergency period with an alternate form of fluid milk or without fluid milk.

Although program operators are expected to meet the fluid milk requirements to the greatest extent possible, supply chain disruptions, including disruptions that limit milk variety or affect serving size, would be considered a temporary emergency condition for purposes of this flexibility.

Strategies for Navigating Fluid Milk Supply Disruption

- Utilize procurement strategies and/or alternate fluid milk vendors. See the USDA's <u>School Meal Supply Chain Issues During School Year 2022-23</u> resource and the CDE's <u>Procurement in School Nutrition Programs</u> web page for more information.
- Provide fluid milk via bulk milk dispensers. See The LunchBox's <u>Bulk Milk</u> web page for information and benefits of bulk milk service.
- Request less variety and streamline your product list. Ensure a minimum of two milk types are available to all students at each meal. One milk type must be unflavored at each meal.
- Provide fluid milk via lesser used forms such as ultra-high temperature shelfstable milk.
- Submit a waiver to the CDE online at https://surveys3.cde.ca.gov/s.asp?k=169057099551 if you are experiencing a shortage of fluid milk due to supply chain disruptions and require the use of the allowable flexibilities to serve reimbursable meals with an alternate form of fluid milk or without fluid milk
