Re: New Legislation Requirements / Yearly Fiscal Status Reports

Dear Mays:

Pursuant to Assembly Bill No. 1666, the Riverside Unified School District must, within seven months after the last day of each fiscal year (starting January 31, 2017), prominently display on its website the following for each CFD:

- Copy of the annual report for that fiscal year pursuant to Section 53343.1
 - Section 53343.1 requires CFDs formed after January 1, 1992 to prepare an annual report including specific information, but only if requested by an interested party
 - To the best of our knowledge, such report has never been requested for any Riverside School District CFD
- Copy of the enclosed Mello-Roos and Marks-Roos Yearly Fiscal Status Reports
